The Maryland Department of Housing and Community Development (DHCD) is committed to enhancing energy efficiency and providing critical home repairs. Through its programs, DHCD ensures residents can access essential home improvements that reduce energy costs and enhance living conditions.

In FY2024, the Department:

- Completed 3,404 energy efficiency projects
- Saved enough electricity (16,589 megawatt hours) to power about 1,500 homes for a year
- Reduced carbon emissions by 47,748 metric tons, equal to planting more than 2.7 million trees

The Maryland Department of Housing and Community Development supports small businesses through grant programs designed to strengthen local economies.

RESTORE_{2.0} Project Restore 2.0 provided \$13.2 million to 55 place-based economic development organizations for businesses to occupy vacant commercial spaces.

Business Boost awarded \$2.1 million to 47 small businesses seeking to expand or establish locations and support economic growth by driving innovation or technology advancements, growing new industries, leveraging existing regional strengths, or were women or minority-owned.

Two historic buildings at 301-305 North Howard Street in Baltimore were transformed into 15 expansive and modern live/work loft apartments, and ground-floor retail spaces to enhance the local community.

Governor Wes Moore, alongside local officials, toured the Oasis Fresh Food Market in Indian Head, funded with \$5.5 million, including \$300,000 from DHCD. The market will offer fresh essentials and feature a community garden in 2025.

With a \$50,000 Business Boost grant, SK Printing expanded production capacity, upgraded equipment, and introduced new services, supporting small business growth and strengthening the local economy.

Jojo's Restaurant and Tap House, located in the vibrant Downtown Frederick Arts and Entertainment District, has undergone new ownership supported by the Neighborhood BusinessWorks (NBW) Program.

The City of Frostburg used \$2.9 million from Maryland's LGIF program to renovate the public safety building into the Frostburg Municipal Center. Upgrades included ADA improvements and enhanced functionality to better serve the community.

The City of Laurel borrowed \$2,860,000 to fund fleet purchases, facilities, and street improvements. Trucks and front loaders support vital services like waste collection, street maintenance, snow removal, and more to keep the community running smoothly.
