## Department Overview

The Maryland Department of Housing and Community **Development partners** with local stakeholders to promote and preserve affordable homeownership and rental housing and empower the revitalization and redevelopment of Maryland's cities, towns, and neighborhoods. Through thoughtful and fiscally prudent investment, the department strives to do the most good for the most Marylanders, improving the quality of their housing, their communities, and their lives



#### **RENTAL HOUSING**

The department administered \$701 million in state and federal financing for 32 projects that created or preserved more than 3,000 units of high quality, energy efficient, affordable rental housing across Maryland. During the FY20 competitive application round, the department awarded more than \$44 million in state funds and federal tax credits to 15 projects. These projects will produce 1,837 affordable units, the largest number of units financed in a single application round. Six projects are located in designated Opportunity Zones, including South Street Centre, which will create 152 units for seniors and families in Frederick, and Sojourner Place at Wolfe, which will create 70 units in Baltimore City, including 35 units set aside for formerly homeless individuals.



#### **BUSINESS LENDING**

In FY20 Neighborhood BusinessWorks surpassed the milestone of more than \$40 million in lending to over 170 small businesses through the Neighborhood BusinessWorks program, effectively tripling program production since the beginning of the Hogan-Rutherford administration in 2015. Neighborhood BusinessWorks provides gap financing to new and expanding small businesses located in Priority Funding Areas and Opportunity Zones across the state. This year the program loaned \$10.6 million, yielding a total economic impact of nearly \$66 million in FY20 alone.



#### MARYLAND MORTGAGE PROGRAM

A significant expansion of its portfolio of products in recent years empowered the Maryland Mortgage Program to reach record performance and receive national recognition. For the first time in its nearly 40-year history, the Maryland Mortgage Program achieved more than \$1 billion in loan activity in a single year through a flexible array of mortgages and down payment assistance, including the Maryland SmartBuy initiative, which eliminates student loan debt as part of a home purchase. The Maryland Mortgage Program's historic performance was recognized by the National Council of State Housing Agencies, which selected it as the award winner in the "Homeownership: Empowering New Buyers" category at the highly-competitive annual Awards for Program Excellence



#### **NEIGHBORHOOD REVITALIZATION**

The department's Neighborhood Revitalization programs enable positive redevelopment that creates jobs, generates tourism, improves streetscapes and infrastructure, and supports critical local services like homelessness prevention. In FY20, Neighborhood Revitalization programs, such as Community Legacy and the federal Community Development Block Grant, provided \$83.7 million to 816 businesses, local governments and community organizations. In Baltimore, Project C.O.R.E. (Creating Opportunities for Renewal and Enterprise) continued to improve neighborhoods throughout the city demolishing, deconstructing, or stabilizing more than 4,300 vacant, blighted units since program inception to make way for new green space, new affordable and mixed-use housing, and small business opportunities





As part of the State of Maryland's response to and recovery from the COVID-19 pandemic, the Maryland Department of Housing and Community Development's efforts were guided by cooperation and compassion. The department provided information and assistance to Maryland homeowners and renters, coordinated response efforts between local homelessness service providers, and provided critical support to community institutions, nonprofits, and businesses.







#### **EVICTION PREVENTION AND RENTAL ASSISTANCE**

Early in the State's response, Governor Hogan issued executive orders to prevent foreclosures and evictions to ensure Maryland's families, seniors, and individuals with disabilities, whether homeowners or renters, could remain safely and securely in their homes even if their ability to pay their rent or mortgage was adversely impacted by COVID-19.

The department provided guidance to homeowners on how to connect with their mortgage company to get relief and reached a 90-day forbearance agreement with many Maryland mortgage lenders and servicers. To assist renters, the department has administered more than \$41 million in state and federal rental funding to thousands of household.

#### **COMMUNITY & HOMELESSNESS SERVICES**

The department's Homelessness Solutions Program team coordinated resources and technical assistance to local service providers known as Continuums of Care - or CoCs - via biweekly calls and newsletters during the onset of the pandemic. Those CoCs were connected with the Maryland Emergency Management Agency to apply for transitional sheltering assistance. The department streamlined its processes to move homelessness assistance funds as quickly as possible to local communities and made those resources more flexible so that service providers could use funding for hotel/motel vouchers, basic supplies, health and hygiene products, and Personal Protective Equipment as warranted by local need. The department also rapidly administered substantial federal grant funding to local governments and Community Action Agencies to support continuation of vital programs and services during the pandemic.

#### MARYLAND NONPROFIT RECOVERY INITIATIVE

The Maryland Nonprofit Recovery Initiative was supported by multiple state agencies and provided grant assistance to nonprofit organizations whose critical operations were financially impacted by COVID-19 and the state-of-emergency. Through the Maryland Department of Housing and Community Development, the Maryland Department of Commerce, and the Maryland State Arts Council, a wide range of nonprofit organizations have received critical funding, including nonprofits licensed by the Maryland Behavioral Health Administration and the Developmental Disabilities Administration. More than \$40 million in awards have been made to more than 1,800 nonprofit organizations across the state with the department administering more than \$32.8 million. These organizations are focused on economic development, health, human services and housing, and employ more than 54,000 Marylanders.

The Maryland Strong Economic Recovery Initiative provided approximately \$43 million in grants through three separate application rounds that support organizations, businesses, and communities that substantially contribute to the economic development and recovery of the state. More than \$8 million was awarded to 32 nonprofit and tourism producing organizations, such as museums, cultural attractions, zoos, aquariums. The initiative also awarded \$30 million to 92 nonprofit and for-profit live music and performance venues, live entertainment promoters, and independently-owned local movie theaters. Finally, \$5 million supported the recovery of local businesses and economic development in designated Main Street Maryland communities.

#### **EXPANDING INTERNET ACCESS FOR UNSERVED STUDENTS**

When schools transitioned to virtual learning due to the COVID-19 pandemic, it quickly became apparent that many students could not access online resources due to a lack of connectivity.

At the end of March 2020, the Governor's Office of Rural Broadband offered emergency funding to schools and libraries to improve their ability to expand existing connectivity efforts, including the installation of external internet access points on buildings and the purchase and distribution of cellular hotspots for student use.

Governor Hogan announced funding for several programs to assist with student connectivity for the fall school year and beyond.
