2019 Point-in-Time (PIT) Count

2019 Point in Time Count Results

6,561 Individuals Identified

- 9.47% Decrease Overall Compared to 2017 (7,247)
- Both Sheltered and Unsheltered Year

Take Aways

- Half of CoCs saw a decrease while half saw an increase
- Largest Decrease by CoC: 27.63%
- Largest Increase by CoC: 22.88%
- Chronic experienced 14.8% Decrease
- Veterans reduced by 8.58%
- More to come

Homelessness Solutions Program (HSP) Data

- Consolidation of programs now allows us to collect information directly from the local HMIS
- Using data quality and performance measures to determine funding amounts

Homelessness Solutions Program (HSP) Data

- Currently available data covers Quarter 1 – Quarter 3 (July 1, 2018 – March 31, 2019)
- 14,560 clients served in the first 9 months of HSP

Emergency Shelter

- 6,113 clients served
- Median LOS, stayers: 90 days
- Median LOS, leavers: 51 days
- **50% exits to permanent housing**

Rapid Re-Housing

- 1,652 clients served
- Median LOS, stayers: 87 days
- Median LOS, leavers: 66 days
- **78% median exits to permanent housing**

PSH STRATEGY

- New development (LIHTC)
- Prioritization of existing units and vouchers
- System movement (HUD funded PSH)
- Project-Based Subsidy – Private Landlords
- Converting existing transitional housing stock
- Other Programs targeted to special populations (811, New Futures, FUP)

BWI HOMELESS OUTREACH

- More than 1,300 duplicated contacts
- Since June, 2018 approximately 47 people have been housed
- Since January 2019, approximately 8 new individuals a month
- Since January more than 10 have received employment
- January-April average 40 per night
