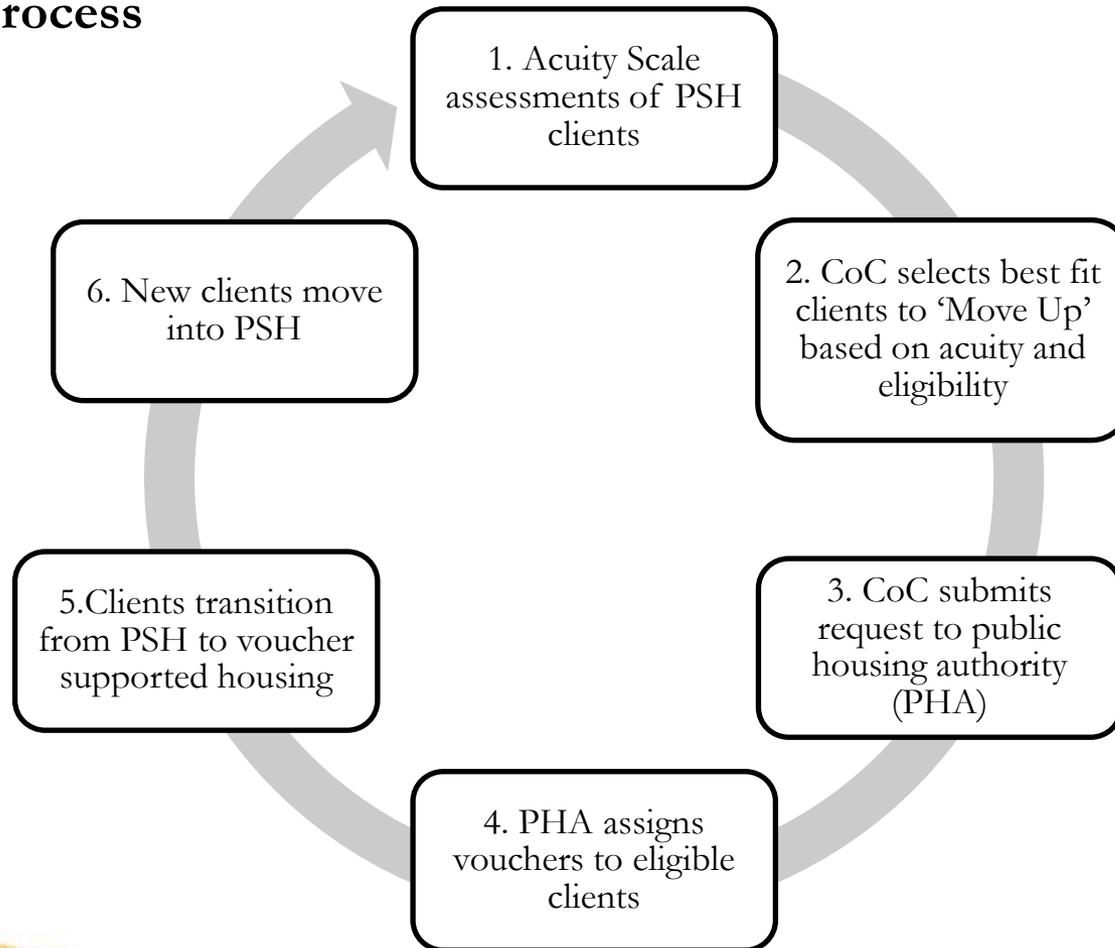

The Move Up Initiative provides an opportunity for eligible PSH residents who no longer need intensive supports, but still require a voucher to remain housed, to 'graduate' from service intensive housing to Section 8 vouchers set aside by the public housing authority.

BWI OUTREACH

- DHCD and BWI partnered to provide outreach to people experiencing homelessness at airport 2018-2019. Prologue, Inc is current service provider.
- BWI will continue providing outreach services via new contract awarded through RFP
- New COMAR changes establish operating hours for the public at BWI – 4am to 11pm (ticketed passengers have access 24/7). Expected to go into effect March 2020.
- Contracted service provider(s) will provide additional outreach ahead of and during transition

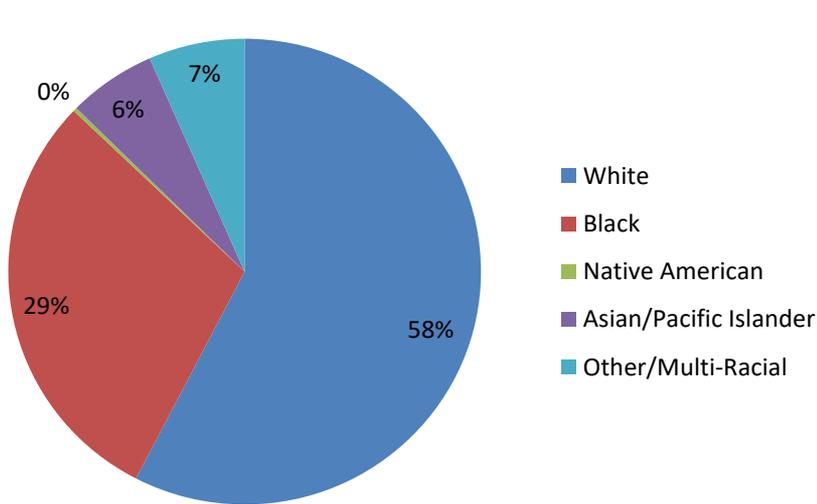
Goal: To explore the homelessness service delivery system through a race equity lens. This study focuses on the varying outcomes, experiences, and service utilization of clients compared across racial groups, as well as the overall demographics of clients in the system.

Phase 1: Quantitative Analysis

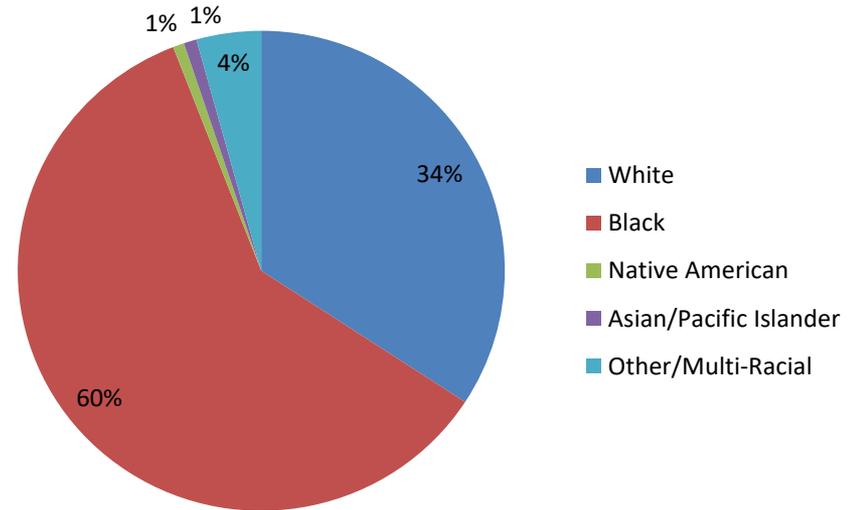

State Population (Race)



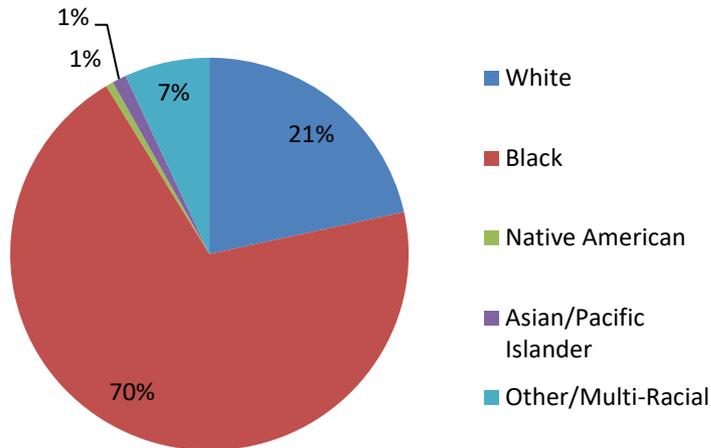
Experiencing Homelessness (Race)



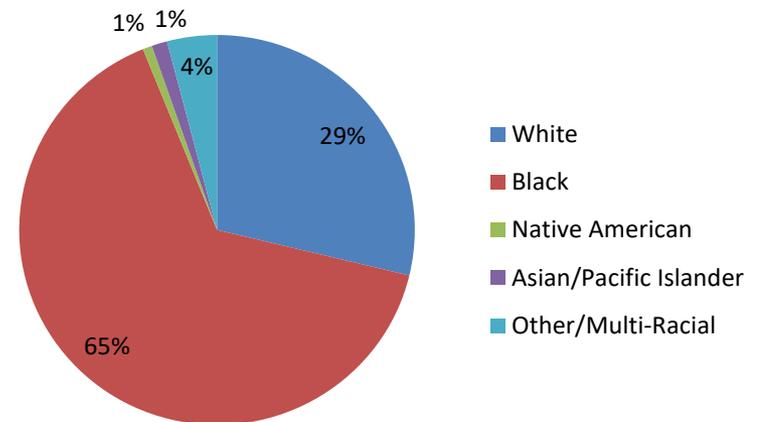
While representing only 29% of the state population, Black people represent 60% of the population experiencing homelessness.

Families Experiencing Homelessness (Race)



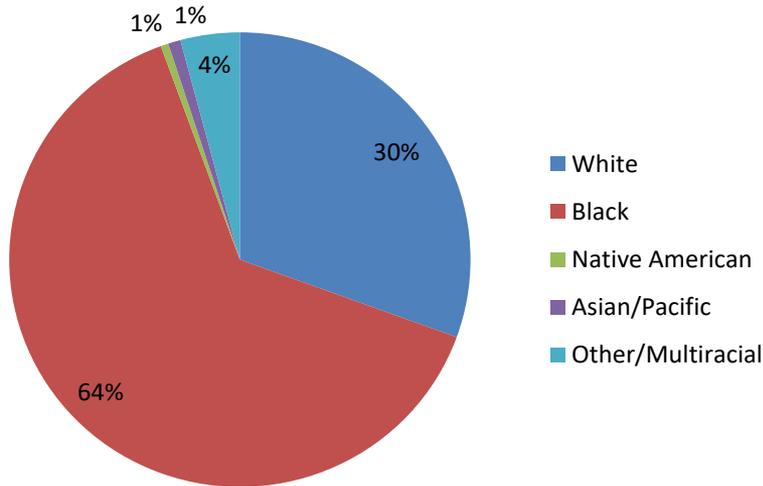
Youth Experiencing Homelessness (Race)



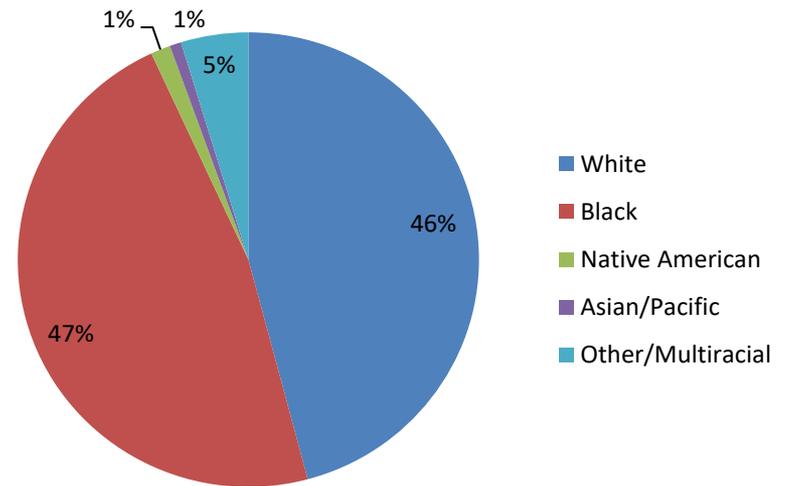
The disparities are greater in the Family (70%) and Youth (65%) sub populations. There is even a greater disparity when looking at some of the CoCs individually.

Sheltered vs. Unsheltered

There is a discrepancy in the Sheltered (64%) and Unsheltered (47%) sub populations.
