Homeless Services Funding News and Updates



Changes in Federal COVID Relief Funding to Address Homelessness

FEMA Non-Congregate Sheltering

- Provided funding from FEMA public assistance for hoteling of people who could not safely isolate or quarantine and to decompress homeless shelters
- Funding ended June 30

CARES Act Emergency Solutions Grant (ESG-CV)

- COVID relief funding for street outreach, emergency shelter, rapid re-housing, homelessness prevention
- Expenditure deadline extended to September 2023
- Some jurisdictions may receive reallocated funds



New/Increased Resources to Address Homelessness in FY2023

Homelessness Solutions Program (State Funding)

- State budget increased program by \$5 million
- Funds are provided to Continuum of Care lead agencies who then subgrant funds to local service providers
- Competitive application each year this year CoCs could apply for normal "renewal" amount as well as additional competitive funds

Maryland Medicaid 1115 Waiver – ACIS Pilot

- Allows Medicaid to pay for housing case management services for people who are homeless as well as those moving into permanent housing
- Requires 50% local match for services
- Can be paired with housing subsidies or affordable/income-based units to create permanent supportive housing
- Recent expansion of pilot will allow hundreds more people to be served across State CoCs, service providers, or local governments that are interested in participating can contact Danielle

New/Increased Resources to Address Homelessness in FY2023

HUD Unsheltered and Rural NOFO

- Competitive funding opportunity for Continuums of Care to apply for permanent housing projects, HMIS, and Coordinated Entry supportive services
- Projects awarded under NOFO will be renewed under normal Continuum of Care funding competition in subsequent years
- All CoCs are eligible to apply for the unsheltered set-aside (no more than 10 CoCs per state will receive funding)
 - CoCs with high unsheltered populations over 1000 will receive bonus points (no Maryland CoCs eligible)
- Maryland jurisdictions eligible for rural set-aside include:
 - Balance of State CoC Garrett County
 - Mid-Shore CoC Caroline, Dorchester, Kent, Talbot Counties

2022 General Assembly Session Key Legislation Update



Enacted Legislation

- HB0521 /CH0722 Sealing of Court Records
 - Shields records for tenants who <u>did not</u> have a judgment of possession entered in favor of the landlord
 - Allows tenants to petition court to shield record for a judgment of possession entered in favor of landlord
- HB0571 /CH0020 (SB0279/CH0021) Access to Counsel Fund
 - Alters the Access to Counsel in Evictions Special Fund to include money received by the Division of Consumer Protection in the Office of the Attorney General from a final settlement, an agreement, or a judgment relating to an investigation or enforcement of the Maryland Consumer Protection Act for an unfair, abusive, or deceptive trade practice for rental residential property, excluding restitution and the costs of the action the Attorney General is entitled to recover.



Enacted Legislation

• <u>HB0932</u> /<u>CH0671</u> (<u>SB0592</u>/<u>CH0672</u>) – Right of Redemption

 A tenant or resident who has the right to redemption of the leased premises by tendering all past due amounts plus court awarded costs and fees may tender those amounts, costs, and fees in an electronic or written check issued by a political subdivision or on behalf of a governmental entity.

HB0824/CH0685 – Eviction Data Collection and Reporting

Requires the Judiciary to collect certain data pertaining to a warrant of restitution or a
writ of possession issued in accordance with a certain judgment for possession of
residential property; requiring the Judiciary to share complete eviction data from the
immediately preceding month with the Department of Housing and Community
Development each month; requiring the Department to make eviction data available in
a certain format to a State or local agency or an academic institution located in the
State. Requires annual report to be submitted.

- <u>HB0367 </u>Landlord and Tenant Repossession for Failure to Pay Rent Rental Assistance Programs
- HB0691 (SB0564) Landlord and Tenant and Wrongful Detainer Actions Eviction Prevention Services
- HB0703 (SB0563) Real Property Actions to Repossess Judgment for Tenants and Proof of Rental Licensure
- HB0712 (SB0521) Landlord and Tenant Access to Counsel in Evictions Special Fund Mandatory Appropriation
- SB0223 (HB0298)/HB0693 Court Surcharge Bills

Workgroup Planning for 2022



Homeless Services Framework

- Last update in 2019 see page 34 in Annual Report for framework and progress updates
- Existing framework goals:
 - GOAL 1 Increase the number of permanent supportive housing options available statewide to those experiencing homelessness.
 - GOAL 2 Improve access to and quality of emergency shelter options available statewide to those experiencing homelessness.
 - GOAL 3 Improve the emergency services network serving the homeless in order to prevent a return to hospitals or jails.
 - GOAL 4 Ensure veterans experiencing homelessness have sustainable housing options and access to necessary supportive services where they live, to prevent a return to homelessness.
 - GOAL 5 Ensure homeless youth 16-24 years of age have access to quality housing, education and employment options statewide.
 - GOAL 6 Reduce or eliminate workforce barriers, increase training opportunities, sustainable employment options and earning potential to ensure those experiencing homelessness can become self-sufficient.
 - GOAL 7 Ensure that people with lived experience have a voice and adequate representation within the Interagency Council on homelessness.
