YOUTH WORK GROUP

The Youth Workgroup last met on June 25, 2019

The Workgroup is currently drafting a report and set of recommendations entitled "A Systems-Level Response to Prevent and End Youth Homelessness in Maryland." This will be a formal update to the 2013 Taskforce Report to highlight successes and achievements made and new challenges to be addressed. The report includes 7 sections relating to education, child welfare, health, economic stability, and housing. Monthly working sessions are held to discuss each section and invite additional stakeholders and subject matter experts to discuss and shape the language of the recommendations.

Many workgroup members are participating in the Workgroup to Study Shelter and Supportive Services for Unaccompanied Homeless Minors led by chairs of the Joint Committee on Homelessness.
