#### End Of Year (EOY) Reporting and Reopening of the Portal

As the owner or sponsor of a property receiving an allocation of Low-Income Housing Tax Credits (LIHTC) you are required to upload certain tenant and project data through a portal provided by the Maryland Department of Housing and Community Development (DHCD), which will ultimately be uploaded by the Department to HUD.

DHCD has decided to re-open the portal to provide an opportunity for uploads not submitted or not fully submitted effective June 30, 2021. The portal will open again on July 16, 2021 and remain open through the close of business on August 2, 2021. The portal functionality will remain the same as both last year and this year. If you have successfully uploaded each project file required of you, no further action is required at this time.

The portal will allow importing of NAHMA XML files version 3.1 or greater (and must have the property name included in the file). NAHMA 1.1 will not be accepted by the system. In lieu of an XML file there is a

manual data entry option. The portal will not accept Excel files. ID numbers provided to you for any previous year's upload are no longer functional.

Continuing failure to comply with EOY upload requirements may compromise your organization's ability to compete for LIHTC allocations and other state funding, and is a ground for the filing of Form 8823.
