Re: 2021 End of Year (EOY) Reporting Updates (see also Notice 22-09)

1. The Portal will be open through July 30, 2022.

2. Properties subject to EOY Data Submission. A list of all properties subject to 2021 EOY Data Submission is provided under the category of "Low Income Housing Tax Credits ProgramCompliance Documents" at the following link:

https://dhcd.maryland.gov/housingdevelopment/pages/mflibrary.aspx#info.

Directly below the list of properties subject to 2021 EOY Data Submission is a matching list. The only difference between these two lists is that the second one sorts the list of Projects by LOAN using the MD Number assigned to each Project. Please look for the MD Number for your Project(s) on this second list to see whether you are required to make a 2021 EOY Data Submission. The MD Number for a project remains the same from the date that the Project is allocated, while in many cases the name of the Project used in our official records differs from the name used by you.

3. <u>Registering your Projects on the Portal.</u> When you click on the link below it will take you to the landing page of our portal which is captioned "Login". Look at the menu in the upper right-hand corner and click "Register". On the "Registration" page find the menu in the upper right-hand corner and use the "Instructions", as necessary, particularly as those instructions provide guidance to uploading XML files. When you have completed the registration of a Project the portal will generate an email to the email address you have just provided on the "Registration" page which will indicate that you have successfully registered the Project. This email will also furnish the recipient with a password for completing the upload. The password is unique to the Project and is only good for this year's data upload.
