2024 Qualified Allocation Plan and Multifamily Rental Financing Program Guide Revision -- Update

The Department has released a draft revision of the Qualified Allocation Plan (the "QAP") and Multifamily Rental Financing Program Guide (the "Guide") for public comment. Thank you to everyone that participated in the Listening Sessions held in June and that submitted written comments. We look forward to continued input from our stakeholders as this process continues.

In Notice 24-6, the Department requested feedback on tenant selection policies, permanent supportive housing, and the Infill and Redevelopment Pool through the Listening Sessions. That feedback resulted in updated requirements for tenant selection policies and new threshold requirements to create permanent supportive housing units. The maximum LIHTC award for the Infill and Redevelopment Pool was also increased to generate greater interest from investors.

We are committed to finalizing revisions to the QAP and Guide in a timely manner to enable our partners to continue to pursue the development of critically-needed affordable rental housing, while providing meaningful opportunities for stakeholder engagement.
