- Except in instances when the BVRC expressly invites public participation, no member of the public attending an open session may participate in the session.
- A person attending an open session may not engage in any conduct, including visual demonstrations, such as the waving of placards, signs, or banners, that disrupts the session or that interferes with the right of members of the public to attend and observe the session.

Meetings Being Recorded

- BVRC meetings are recorded.
- A member of the public, including any representative of the news media, may record an open session of BVRC; the recording cannot create an excessive noise that disturbs members of the BVRC or other persons attending the session.

3,168 total blocks in the vacancy reduction priority geographies308 blocks in FY25 block-level planning

2,868 properties on those blocks all have strategies assigned:

- o 1,568 currently open VBNs
 - 126 VBNs have been abated on the BLP blocks in FY25
 - 650 open VBNs are included in the FY25 BVRI funding request
- o 1,300 vacant lots

MD DHCD's FY26 BVRI Round

- Application closed May 23
- 89 applications received, including applications for whole block target areas and single site projects
- Next steps:
 - City/State DHCDs reviewing property pipeline to determine overlapping CDO/City property strategies and determining readiness to proceed
 - DHCD/MCIC reviewing full applications through June 13
