NOTICE IS HEREBY GIVEN that pursuant to the applicable provisions of the governing documents, Manufacturers and Traders Trust Company, as Successor Trustee, hereby calls for special redemption on **December 24, 2021** (Redemption Date), **\$6,955,000** principal amount of the Bonds at a redemption price equal to 100% of the principal amount thereof plus accrued interest to the Redemption Date; provided, however, such redemption shall be conditioned upon the occurrence of the issuance of Community Development Administration Department of Housing and Community Development State of Maryland Residential Revenue Bonds 2021 Series C on or before the Redemption Date.

IF THE CONDITION DESCRIBED ABOVE FAILS TO BE SATISFIED AS OF THE DATES SO SPECIFIED, THIS REDEMPTION NOTICE SHALL BE OF NO FORCE AND EFFECT, THE REDEMPTION SHALL BE CANCELLED AND THE BONDHOLDERS SHALL BE RESTORED TO THEIR FORMER POSITIONS AS THOUGH NO SUCH NOTICE OF REDEMPTION HAD BEEN DELIVERED.

The CUSIP number, interest rate, maturity date, and amount of the Bonds called for special redemption are as follows:

Registered Bonds called, in its entirety, in the amount of \$2,995,000
