LOCAL GOVERNMENT INFRASTRUCTURE BONDS (SENIOR OBLIGATIONS), 2010 SERIES A-1

NOTICE IS HEREBY GIVEN of the election by the Community Development Administration (the "Administration") to redeem on August 21, 2020 (the "Redemption Date") a portion of its outstanding Infrastructure Bonds (Senior Obligations), 2010 Series A-1 dated as of August 25, 2010 (the "2010 Bonds") in the amount of \$7,910,000 (the "Bonds"). The Bonds are stated to mature and bear interest as follows:

If the conditions to such redemption described below are satisfied, the Bonds will be redeemed on the Redemption Date at the redemption prices set forth above as percentages of the respective Redemption Amount, together with interest accrued to the Redemption Date, to be paid in accordance with Section 4.05 of the Resolution Providing for the Issuance of Local Government Infrastructure Bonds of the Administration adopted as of August 1, 2020, as amended. From and after the Redemption Date, interest on the Bonds will cease to accrue.

The Bonds will not be redeemed if, on the Redemption Date, there is not on deposit with the Trustee money sufficient to pay the principal amount of the Bond and accrued interest to the Redemption Date.
