- **c. LIHTC Supportive Housing Set Aside** -Heather Sheridan, Associate Director of Homelessness initiatives, Department of Housing and Community development.
 - i. PSH Set-Aside in our LIHTC Process (QAP)
 - 1. This is the first time the State of Maryland has had this!
 - 2. Affordable up to 35% AMI
 - 3. No more than 50% of units identified as PSH
 - 4. Must have Project-Base Rental Assistance committed
 - 5. Letter of Support required from the CoC
 - 6. Supportive Services plan which is acceptable to DHCD
 - 7. Low Barrier entry requirements for Housing
 - ii. Worked with partners in Community Development Administration (CDA) and the Corporation for Supportive Housing (CSH) who provided technical assistance throughout December and January on this strategy

- **d. SAMSHA Award to MDH or Opioid Response** Heather Sheridan, Associate Director of homelessness initiatives, Department of Housing and Community Development.
 - \$66 million (over 2 years) awarded to MDH for communities impacted by the Opioid Crisis
 - Up to \$1.8 million dedicated to Recovery Housing (either Expansion or New)
 - (Note: Funds CANNOT be used for Rental Assistance)

- **e. Permanent Supportive Housing (PSH) Strategy** Heather Sheridan, Associate Director, Homelessness initiatives, DHCD

DHCD/ ICH Housing Goals:

- 1. Increasing housing options for approx. 5,000 chronic homeless, youth & veterans over the next 5 years.
- 2. Approximately 3,500 chronic homeless across the state.
- 3. Need 900 RRH Placements needed over the next 3 years
- 4. Need 2,800 permanent housing placements over the next 5 years

Strategy:

- New Construction Low Income Housing Tax Credits (LIHTC) Permanent Supportive Housing (PSH) set-aside
- 2. Public Housing Authorities (PHAs) Dedicating tenant-based vouchers and existing units to the homeless.
- 3. HUD-Funded PSH 8500 across the state.
- 4. Project-Based Contract Admin. (Private Landlords)
 - A. Approx. 20,000 Units statewide.
 - B. Developing relationships with them and CoCs
 - C. Encouraging them to prioritize their recruitment from CoC
- 5. Other DHCD Programs
 - A. Weinberg
 - B. 811
 - C. STHFG Program Just increased by \$1 million
- 6. Conversion of existing transitional housing into PSH
- 7. Meetings happening with the 17 other housing authorities statewide
